# Høvuðspunkt

## Fastnet telefoni

- Tað voru 18,9 túsund fastnet telefonhald ultimo juni 2017, ein minking uppá 500 hald (2,7%) samanborið við somu tíð árið frammanundan. Tað voru 2,2 túsund VoIP hald ultimo juni 2017. Hetta er ein øking uppá 15%, samanborið við ultimo juni 2016.

## Fartelefoni

- Tað voru 58,4 túsund fartelefonhald ultimo juni 2017, ein vökstur uppá 4.900 hald (9,2%) samanborið við eitt ár frammanundan. Út av teimum 4.900 nýggju haldunum voru 3.900 (80,1%) frammanundan goldin (prepaid). Føroya Tele átti 83% av samlaðu hækkingini í fartelefonhaldum, og økti harvið sín marknaðarparti við 0,8%.
- Við endan av fyrru hálvú av 2017 voru tað 3.000 maskinu-til-maskinu (M2M) fartelefonhald, ein vökstur á 300 hald (12%) samanborið við eitt ár frammanundan. Ultimo juni 2017 voru 98,1% av öllum M2M haldum vinnulig hald.

## Internet

- Fastnet breiðband taldi 18,2 túsund hald við endan av fyrru hálvú av 2017, ein minking uppá 800 hald (4,1%) samanborið við somu tíð árið fyri. Talið av fastnet breiðbandshaldum við einari lýstari ferð yvir 10 Mbit/s øktist hinvegin seinasta árið við 10% til 15,2 túsund ultimo juni 2017. Av öllum fastnet breiðbandshaldunum, høvdu 83% eina lýsta ferð omanfyri 10 Mbit/s ultimo juni 2017.
- Tað voru 44,2 túsund virkin mobil internethald við endan av fyrru hálvú av 2017, ein øking við 7.200 haldum (19,5%) samanborið við somu tíð árið frammanundan. Talið av fartelefonhaldum við atgongd til data øktist til 42,3 túsund við endan av fyrru hálvú av 2017. Harvið høvdu 72,4% av öllum fartelefonhaldum atgongd til data. Av öllum virknum mobilum internethaldum voru 70,8% privat ultimo juni 2017.

## Ferðsla

- Fastnet linjur framleiddu 13,7 mió. minutir útgangandi kall í fyrra hálvár 2017, ein minking uppá 2,9 mió. minutir (17,3%) samanborið við fyrra hálvár 2016. Í miðal framleiddi hvør fastnet telefon 790,5 útgangandi minutir í leypi av fyrru hálvú av 2017, sum er 63,4 minutir (7,4%) færri samanborið við sama tíðarskeið árið frammanundan.
- Fartefoni kervini framleiddu 72,2 mió. minutir útgangandi kall fyrra hálvár 2017. Samanborið við sama tíðarskeið árið frammanundan, er talan um eina øking við 4,6 mió. (6,8%). Í miðal framleiddi hvort fartelefonhald 1.235,7 útgangandi minutir í leypi av fyrra hálvári 2017. Hetta er ein minking uppá 27,6 minutir (2,2%) fyri hvort haldið, samanborið við fyrra hálvár 2016.
- Internetferðslan yvir mobilt breiðband heldur fram at vaksa í stórum. Mobil breiðbandshald framleiddu 924,3 mió. MB fyrra hálvár 2017. Hetta er ein hækking uppá heili 285,3% samanborið við sama tíðarskeið árið fyri.



# Highlights

## Fixed telephony

- There were 18.9 thousand fixed-telephone subscriptions at end of 1H 2017, a decrease of 500 (2.7%) compared to a year previously. VoIP subscriptions increased to 2.2 thousand subscriptions by end of 1H 2017, 15% more compared to end of 1H 2017.

## Mobile telephony

- There were 58.4 thousand mobile subscriptions at the end of 1H 2017, an increase of 4,900 (9.2%) compared to a year previously. Of the 4,900 new subscriptions, 3,900 (80.1%) were prepaid. Føroya Tele counted 83% of the total increment in mobile-subscriptions, and shifted the market share by 0.8 percentage points in Føroya Tele's favour.
- By end of 1H 2017 there were 3,000 Machine-to-Machine (M2M) mobile-subscriptions, an increase of 300 subscriptions (12%) compared to one year prior. By end of 1H 2017, 98.1% of all M2M subscriptions were business subscriptions.

## Internet

- Fixed-broadband counted 18.2 thousand subscriptions by end of 1H 2017, a decrease of 800 (4.1%) compared to a year previously. The number of fixed broadband subscriptions with an advertised speed above 10 Mbit/s increased however during the same period by 10 percentage points to 15.2 thousand subscriptions by end of 1H 2017. Of all fixed broadband subscriptions, 83% had an advertised speed above 10 Mbit/s by end of 1H 2017.
- There were 44.2 thousand active mobile-internet subscriptions by the end of 1H 2017, an increase of 7,200 (19.5%) compared to one year before. The number of mobile telephone subscriptions with data access increased to 42.3 thousand by end of 1H 2017. Thereby, 72.4% of all mobile-telephone subscriptions had data access by the end of 1H 2017. Of all active mobile-internet subscriptions, 70.8% were to private consumers at the end of 1H 2017.

## Traffic

- The fixed lines generated 13.7 million minutes of outgoing calls in 1H 2017, a fall of 2.9 million minutes (17.3%) compared to 1H 2016. In average, each fixed-telephone subscription generated 790.5 minutes of outgoing calls during 1H 2017, that is 63.4 minutes (7.4%) less compared to the same period the previous year.
- The mobile networks generated 72.2 million minutes of outgoing calls in 1H 2017. Compared to the same period the year before, an increase of 4.6 million minutes (6.8%). A mobile subscription generated 1,235.7 minutes outgoing calls in average during 1H 2017, a decrease of 27.6 minutes (2.2%) per subscription compared to 1H 2016.
- Mobile-broadband internet traffic continues to increase drastically. All mobile-broadband subscriptions generated 924.3 million MB in 1H 2017, an increase of 285.3% compared to the same period a year previously.

The calculation of fixed-telephone subscriptions has been adjusted to give a more correct split between PSTN and ISDN lines. All carrier pre-selected lines were reported as PSTN lines before 2016, although these also contained ISDN lines. Therefore, data on PSTN and ISDN lines from first half of 2016 will not be directly comparable to previous periods.

Broytingar í veitaraforvali koma fyri tá kundar skifta veitara, tá ein kundi stovnar hald og samstundis velur veitaraforval, og tá kundi sum hevur veitaraforval strikar haldið. Tað hevur ikki verið möguligt at uppgera flytingarnar serstakt, og tí visir talið fleiri "porteringar" enn rætt er.

Since there is only one provider of the physical fixed network, fixed numbers are ported by changing the carrier pre-selection prefix. However, it has not been possible to screen out transferred numbers only. Hence, this figure contains transferred numbers as well as new or terminated numbers.

Bólkningin "Ferð yvir 2 Mbit/s til og við 10 Mbit/s" varð broytt til "2 Mbit/s upp til men undir 10 Mbit/s", sum elvdi til at eitt 10 Mbit/s hald ikki longur var partur av hesi bólkningini, eins og tað var frammanundan. Tískil vóru öll 10 Mbit/s hald flutt "ein bólk upp" til bólin "10 Mbit/s ella hægri", sum fyrr æt "Ferð yvir 10 Mbit/s". A sama hátt vóru öll 2 Mbit/s hald flutt "ein bólk upp", so tey nú eru í bólknum "2 Mbit/s upp til men undir 10 Mbit/s". Hartil vóru öll hald við 10 Mbit/s ella hægri ferð bóldað meira nágreiðiliga í undirbólkar. Í øðrum lagi varð greiningin av ljósleiðara haldum eftir ferð tillagað í fyrru hálvu av 2016, so greiningin nú svarar til greiningina sum er nýtt fyrir DSL, jb. omanfyri. Loksins varð greiningin av FWA haldum tillagað í seinnu hálvu av 2016, so hesi nú eisini eru greinað samsvarandi DSL og ljósleiðara.

The grouping of fixed-broadband subscriptions has been adjusted in order to comply with the ITU guidelines. These adjustments have resulted in a shift in how subscriptions are grouped by speed. First, the grouping of DSL subscriptions was adjusted from first half of 2015. The grouping "Speed above 2 Mbit/s but less than 10 Mbit/s" was changed to "2 Mbit/s to less than 10 Mbit/s", causing a 10Mbit/s subscription no longer to be included in this group as it would have been previously. Therefore, all 10 Mbit/s subscriptions was moved one level up to a new group: "10 Mbit/s and above". Similarly, all 2 Mbit/s subscriptions was moved up one level and included into the "2 Mbit/s to less than 10 Mbit/s" group. Furthermore, subscriptions with speed of 10 Mbit/s or more were detailed into sub-groups. Secondly, fibre subscriptions were adjusted in first half of 2016 so the new grouping corresponds to the DSL-grouping described above. Finally, the grouping of FWA subscriptions was adjusted to correspond to the DSL and fibre grouping in second half of 2016.
