Høvuðspunkt

Fastnet telefoni

- Tað voru 16,7 túsund fastnet telefonhald ultimo juni 2019, ein minking uppá 745 hald (4,3%) samanborið við somu tíð árið frammanundan. Tað voru 2,8 túsund VoIP hald ultimo juni 2019. Hetta er ein øking uppá 410 hald (17,2%), samanborið við ultimo juni 2018.

Fartelefoni

- Tað voru 56,8 túsund fartelefondhaldu ultimo juni 2019, ein minking uppá 2.500 hald (4,3%) samanborið við eitt ár frammanundan. Bæði talið av forút- og eftirgoldnum haldum minkaði í tíðarskeiðinum. Forútgoldin hald fækkaðu til 34,4 túsund (1,9%), og eftirgoldin hald fækkaðu til 22,8 túsund (7,8%). Við endan av fyrru hálvú av 2019, hevði Føroya Tele ein marknaðarpart á 75%. Hey átti tey írestandi 25% av marknaðinum.
- Við endan av fyrru hálvú av 2019 voru tað 3.700 maskinu-til-maskinu (M2M) fartelefondhaldu, ein vökstur á umleið 500 hald (15%) samanborið við eitt ár frammanundan. Ultimo juni 2019 voru 91,8% av øllum M2M haldum vinnulig hald.

Internet

- Fastnet breiðband taldu 18 túsund hald við endan av fyrru hálvú av 2019, óbroytt samanborið við somu tíð árið fyri. Samstundis hækkaði talið av haldum við einari marknaðarfördari ferð á omanfyri 30 Mbit/s við 1.700 (24%), meðan hald við einari marknaðarfördari ferð á undir 30 Mbit/s minkaði samsvarandi (17%). Av øllum fastnet breiðbandshaldum høvdu 50% eina marknaðarfölda ferð omanfyri 30 Mbit/s við endan av fyrru hálvú av 2019.
- Tað voru 49 túsund virkin mobil internethald við endan av fyrru hálvú av 2019, ein øking við 1.000 haldum (1,7%) samanborið við somu tíð árið frammanundan. Talið av fartelefondhaldu við atgongd til data øktist til 46 túsund við endan av fyrru hálvú av 2019. Harvið høvdu 81% av øllum fartelefondhaldu atgongd til data.

Ferðsla

- Fastnet linjur framleiddu 181 túsund tímar útgangandi kall í fyrra hálvár 2019, ein minking uppá 16 túsund tímar (9%) samanborið við fyrra hálvár 2018. Í miðal framleiddi hvør fastnet telefon 11 útgangandi tímar í leypi av fyrru hálvú av 2019, sum er 28 minuttir (4%) færri samanborið við sama tíðarskeið árið frammanundan.
- Fartelefoni kervini framleiddu 1,3 mió. tímar útgangandi kall fyrra hálvár 2019. Samanborið við sama tíðarskeið árið frammanundan, er talan um eina øking við 30 túsund tímar (2%). Í miðal framleiddi hvort fartelefondhaldu 23 útgangandi tímar í leypi av fyrra hálvári 2019. Hetta er ein øking uppá 1,5 tímar (7%) fyri hvort haldið, samanborið við fyrra hálvár 2018.
- Internetferðslan yvir mobilt breiðband heldur fram at vaksa. Mobil breiðbandshald framleiddu 2,8 mió. GB fyrra hálvár 2019. Hetta er ein hækking uppá 46% samanborið við sama tíðarskeið árið fyri.



Highlights

Fixed telephony

- There were 16.7 thousand fixed-telephone subscriptions at end of 1H 2019, a decrease of 745 subscriptions (4.3%) compared to a year previously. VoIP subscriptions increased to 2.8 thousand subscriptions by end of 1H 2019, 410 subscriptions (17.2%) more compared to end of 1H 2018.

Mobile telephony

- There were 56.8 thousand mobile subscriptions at the end of the 1H 2019, a decrease of more than 2.5 thousand subscriptions (4.3%) compared to a year previously. Both the number of pre- and postpaid subscriptions decreased during this period. Prepaid subscriptions decreased to 34.4 thousand (1.9%) and postpaid to 22.8 thousand (7.8%). By the end of 1H 2019, Føroya Tele held a marked share of 75%. Hey held the remaining 25% market share.
- By end of 1H 2019 there were 3.7 thousand Machine-to-Machine (M2M) mobile-subscriptions, an increase of approximately 500 subscriptions (15%) compared to one year prior. By end of 1H 2019, 91.8% of all M2M subscriptions were business subscriptions.

Internet

- Fixed broadband counted 18 thousand subscriptions by the end of 1H 2019, unchanged compared to a year previously. Fast speed connections continue increasing. While, subscriptions with an advertised speed above 30 Mbit/s increased by 1.7 thousand (24%), subscriptions with an advertised speed below 30 Mbit/s decreased equivalently (17%). Of all fixed broadband subscriptions, 50% had an advertised speed above 30 Mbit/s by end of 1H 2019.
- There were 49 thousand active mobile-internet subscriptions by the end of 1H 2019, an increase of about 1 thousand (1.7%) compared to one year before. At the end of 1H 2019, the number of mobile telephone subscriptions with data access increased to 46 thousand. Thereby, 81% of all mobile-telephone subscriptions had data access by the end of 1H 2019.

Traffic

- The fixed lines generated 181 thousand hours of outgoing calls in 1H 2019, a fall of 16 thousand hours (9%) compared to 1H 2018. In average, each fixed-telephone subscription generated 11 hours of outgoing calls during 1H 2019, that is 28 minutes (4%) less compared to the same period the previous year.
- The mobile networks generated 1.3 million hours of outgoing calls in 1H 2019. Compared to the same period the year before, an increase of 30 thousand hours (2%). A mobile subscription generated 23 hours outgoing calls in average during 1H 2019, an increase of 1.5 hours (7%) per subscription compared to 1H 2018.
- Mobile-broadband internet traffic continues to increase. All mobile-broadband subscriptions generated 2.8 million GB in 1H 2019, an increase of 46% compared to the same period a year previously.

¹ Við tað at vit bert hava ein veitara av fastneti, verða fastnet nummur í Føroyum flutt millum veitarnar við at broyta veitaraforval. Broytingar í veitaraforvali koma fyri tá kundar skifta veitara, tá ein kundi stovnar hald og samstundis velur veitaraforval, og tá kundi sum hevur veitaraforval strikar haldið. Tað hevur ikki verið möguligt at uppgera flytingarnar serstakt, og tí visir talið fleiri "porteringar" enn rætt er.

Since there is only one provider of the physical fixed network, fixed numbers are ported by changing the carrier pre-selection prefix. However, it has not been possible to screen out transferred numbers only. Hence, this figure contains transferred numbers as well as new or terminated numbers.
