Høvuðspunkt

Fastnet telefoni

- Tað vóru 15,5 túsund fastnet telefonhald ultimo juni 2020, ein minking uppá 1.200 hald (7,1%) samanborið við somu tíð árið frammanundan. Tað vóru 3,2 túsund VoIP hald ultimo juni 2020. Hetta er ein øking uppá 440 hald (15,7%), samanborið við ultimo juni 2019.

Fartelefoni

- Tað vóru 57,1 túsund fartelesonhald ultimo juni 2020, ein minking uppá 300 hald (0,5%) samanborið við eitt ár frammanundan. Hóast lækkingina av haldum, hækkaði talið av frammanundan goldnum haldum við 3.000 haldum (8,6%) til 37.000 hald hetta tíðarskeiðið. Við endan av fyrru hálvu av 2020, hevði Føroya Tele ein marknaðarpart á 76%, sum er 1% meira enn somu tíð árið frammanundan. Hey átti tey írestandi 24% av marknaðinum.
- Við endan av fyrru hálvu av 2020 vóru tað 4 túsund maskinu-til-maskinu (M2M) fartelesonhald, ein vøkstur á umleið 300 hald (8,9%) samanborið við eitt ár frammanundan. Ultimo juni 2020 vóru 98% av øllum M2M haldum vinnulig hald.

Internet

- Fastnet breiðband taldu 18,4 túsund hald við endan av fyrru hálvu av 2020, nærur 300 hald (1,5%) fleiri samanborið við árið fyri. Samstundis hækkaði talið av haldum við einari marknaðarførdari ferð á omanfyri 30 Mbit/s við 1.500 (17%), meðan hald við einari marknaðarførdari ferð á undir 30 Mbit/s minkaði samsvarandi (14%). Av øllum fastnet breiðbandshaldum høvdu 57% eina marknaðarførda ferð omanfyri 30 Mbit/s við endan av fyrru hálvu av 2020.
- Tað vóru 55 túsund virkin mobil internethald við endan av fyrru hálvu av 2020, ein øking við 5.900 haldum (11,9%) samanborið við somu tíð árið frammanundan. Talið av fartelesonhaldum við atgongd til data øktist til 51 túsund við endan av fyrru hálvu av 2020. Harvið høvdu 90% av øllum fartelesonhaldum atgongd til data. Av øllum virknum mobilum internethaldum vóru 71,4% privat ultimo juni 2020.

Ferðsla

- Fastnet linjur framleiddu 200 túsund tímar útgangandi kall í fyrra hálvár 2020, ein øking uppá 21 túsund tímar (10,6%) samanborið við fyrra hálvár 2019. Í miðal framleiddi hvør fastnet telefon 13 útgangandi tímar í leypi av fyrru hálvu av 2020, sum er 2,2 tímar (16,9%) meira samanborið við sama tíðarskeið árið frammanundan.
- Fartelesoni kervini framleiddu 1,6 mió. timar útgangandi kall fyrra hálvár 2020. Samanborið við sama tíðarskeið árið frammanundan, er talan um eina øking við 0,3 mió. (18,1%). Í miðal framleiddi hvørt fartelesonhald 28,5 útgangandi timar í leypi av fyrra hálvári 2020. Hetta er ein øking uppá 5 timar (21,5%) fyri hvørt haldið, samanborið við fyrra hálvár 2019.
- Fyri fyrstu ferð síðan data savnan byrjaði í 2007, minkar nýtslan av mobilari breiðbandsferðslu. Í fyrru hálvu av 2020 framleiddu øll mobil breiðbandshald 2,6 mió. GB av mobilari breiðbandsferðslu, sum er ein lækking við 2% samanborið við sama tíðarskeið árið fyri.



Highlights

Fixed telephony

- There were 15.5 thousand fixed-telephone subscriptions at end of 1H 2020, a decrease of 1,200 subscriptions (7.1%) compared to a year previously. VoIP subscriptions increased to 3.2 thousand subscriptions by end of 1H 2020, 440 subscriptions (15.7%) more compared to end of 1H 2019.

Mobile telephony

- There were 57.1 thousand mobile subscriptions at the end of the 1H 2020, a slight decrease of 300 subscriptions (0.5%) compared to a year previously. Despite the general decrease in subscriptions the number of prepaid subscriptions increased by three thousand (8.6%) to 37 thousand during this period. By the end of 1H 2020, Føroya Tele held a marked share of 76%, one percentage point more than at the same time one year prior. Nema held the remaining 24% market share.
- By end of 1H 2020 there were four thousand Machine-to-Machine (M2M) mobile-subscriptions, an increase of 300 subscriptions (8.9%) compared to one year prior. By end of 1H 2020, 98% of all M2M subscriptions were business subscriptions.

Internet

- Fixed-broadband counted 18.4 thousand subscriptions by the end of 1H 2020, nearly 300 subscriptions (1.5%) more compared to a year previously. While, subscriptions with an advertised speed above 30 Mbit/s increased by 1.5 thousand (17%), subscriptions with an advertised speed below 30 Mbit/s decreased equivalently (14%). Of all fixed broadband subscriptions, 57% had an advertised speed above 30 Mbit/s by end of 1H 2020.
- There were 55 thousand active mobile-internet subscriptions by the end of 1H 2020, an increase of 5.9 thousand (11.9%) compared to one year before. At the end of 1H 2020, the number of mobile telephone subscriptions with data access increased to 51.2 thousand. Thereby, 90% of all mobile-telephone subscriptions had data access by the end of 1H 2020. By the end of 1H 2020, of all active mobile-internet subscriptions 71.4% were to private consumers.

Traffic

- The fixed lines generated 200 thousand hours of outgoing calls in 1H 2020, an increase of 21 thousand hours (10.6%) compared to 1H 2019. In average, each fixed-telephone subscription generated 13 hours of outgoing calls during 1H 2020, equal to an increase of 2.2 hours (16.9%) pr subscription compared to the same period the previous year.
- The mobile networks generated 1.6 million hours of outgoing calls in 1H 2020. Compared to the same period the year before, an increase of 0.3 million hours (18.1%). A mobile subscription generated 28.5 hours outgoing calls in average during 1H 2020, an increase of 5 hours (21.5%) per subscription compared to 1H 2019.
- For the first time, since data collection started in 2007, the consumption of mobile-broadband internet traffic decreases. During 1H 2020, all mobile-broadband subscriptions generated 2.6 million GB of mobile-broadband internet traffic, a decrease of 2% compared to the same period a year previously.

Broytningar í veitararforvali koma fyrri tá kundar skifta veitara, tá ein kundi stovnar hald og samstundis velur veitararforval, og tá kundi sum hevur veitararforval strikar haldið. Tað hevur ikki verið møguligt at uppgera flytingarnar serstakt, og tí visir talið fleiri "porteringar" enn rætt er.

Since there is only one provider of the physical fixed network, fixed numbers are ported by changing the carrier pre-selection prefix. However, it has not been possible to screen out transferred numbers only. Hence, this figure contains transferred numbers as well as new or terminated numbers.

It should be noted that ported number-blocks are included. Therefore, the figure also includes numbers not in use at the moment.

Føroya Tele's core mobile product for private consumers "ver", is categorized as prepaid which is unchanged compared to the previous statistical publications.
