# Høvuðspunkt

## Fastnet telefoni

- Tað vóru 15 túsund fastnet telefonhald ultimo juni 2021, ein minking uppá 600 hald (3,7%) samanborið við somu tíð árið frammanundan. Tað vóru 3,9 túsund VoIP hald ultimo juni 2021. Hetta er ein øking uppá 680 hald (21%), samanborið við ultimo juni 2020.

## Fartelefoni

- Tað vóru 59,7 túsund fartelesonhald ultimo juni 2021, ein vøkstur uppá 2.600 hald (4,6%) samanborið við eitt ár frammanundan. Við endan av fyrru hálvu av 2021, hevði Føroya Tele ein marknaðarpart á 76%, Nema hevði 23% av marknaðinum, meðan nýstovnaðu Tosa átti tað írestandi 1% av marknaðinum.<sup>1</sup>
- Við endan av fyrru hálvu av 2021 vóru tað 5,5 túsund maskinu-til-maskinu (M2M) fartelesonhald, ein vøkstur á umleið 1.400 hald (34,3%) samanborið við eitt ár frammanundan. Ultimo juni 2021 vóru meira enn 98% av øllum M2M haldum vinnulig hald.

## Internet

- Fastnet breiðband taldu 18,9 túsund hald við endan av fyrru hálvu av 2021, meira enn 500 hald (2,8%) fleiri samanborið við árið fyri. Samstundis hækkaði talið av haldum við einari marknaðarførdari ferð á omanfyri 30 Mbit/s við 1.600 (15,6%), meðan hald við einari marknaðarførdari ferð á undir 30 Mbit/s minkaði samsvarandi (14,2%). Av øllum fastnet breiðbandshaldum høvdu 64% eina marknaðarførda ferð omanfyri 30 Mbit/s við endan av fyrru hálvu av 2021.
- Tað vóru 59 túsund virkin mobil internethald við endan av fyrru hálvu av 2021, ein øking við 3.700 haldum (6,7%) samanborið við somu tíð árið frammanundan. Talið av fartelesonhaldum við atgongd til data øktist til 53 túsund við endan av fyrru hálvu av 2021. Harvið høvdu næstan 90% av øllum fartelesonhaldum atgongd til data. Av øllum virknum mobilum internethaldum vóru 71% privat ultimo juni 2021.

## Ferðsla

- Fastnet linjur framleiddu 170 túsund tímar útgangandi kall í fyrra hálvár 2021, ein minking uppá 32 túsund tímar (16%) samanborið við fyrra hálvár 2020. Í miðal framleiddi hvør fastnet telefon 11 útgangandi tímar í leypi av fyrru hálvu av 2021, sum er 1,7 tímar (12,8%) minni samanborið við sama tíðarskeið árið frammanundan.
- Fartelefoni kervini framleiddu 1,6 mió. timar útgangandi kall fyrra hálvár 2021. Samanborið við sama tíðarskeið árið frammanundan, er talan um eina øking við 4,3 túsund tímar (0,3%). Í miðal framleiddi hvørt fartelesonhald 27,3 útgangandi tímar í leypi av fyrra hálvári 2021. Hetta er ein minking uppá 1 tíma (4,1%) fyri hvørt haldið, samanborið við fyrra hálvár 2020.
- Í fyrru hálvu av 2021 framleiddu øll mobil breiðbandshald 3,6 mió. GB av mobilari breiðbandsferðslu. Nýtslan fevnir um øll nýtslan hjá føroyski mobil breiðbandshald, bæði í og uttanfyri Føroyar. Tað er ein hækking á 900 túsund GB (33%) samanborið við sama tíðarskeið árið fyri.

# Highlights

## Fixed telephony

- There were 15 thousand fixed-telephone subscriptions at end of 1H 2021, a decrease of 600 subscriptions (3.7%) compared to a year previously. VoIP subscriptions increased to 3.9 thousand subscriptions by end of 1H 2021, 680 subscriptions (21%) more compared to end of 1H 2020.

## Mobile telephony

- There were 59.7 thousand mobile subscriptions at the end of the 1H 2021, an increase of 2.600 subscriptions (4.6%) compared to a year previously. Prepaid subscriptions counts 85.4% of the increase in mobile subscriptions. Føroya Tele held a marked share of 76%, Nema held 23% market share, while the newly established provider Tosa held the remaining 1% market share.<sup>2</sup>
- By end of 1H 2021 there were 5.5 thousand Machine-to-Machine (M2M) mobile-subscriptions, an increase of 1.400 subscriptions (34.3%) compared to one year prior. By end of 1H 2021, 98% of all M2M subscriptions were business subscriptions.

## Internet

- Fixed-broadband counted 18.9 thousand subscriptions by the end of 1H 2021, more than 500 subscriptions (2.8%) more compared to a year previously. While, subscriptions with an advertised speed above 30 Mbit/s increased by 1.6 thousand (15.6%), subscriptions with an advertised speed below 30 Mbit/s decreased equivalently (14.2%). Of all fixed broadband subscriptions, 64% had an advertised speed above 30 Mbit/s by end of 1H 2021.
- There were 59 thousand active mobile-internet subscriptions by the end of 1H 2021, an increase of 3.7 thousand (6.7%) compared to one year before. At the end of 1H 2021, the number of mobile telephone subscriptions with data access increased to 53 thousand. Thereby, 90% of all mobile-telephone subscriptions had data access by the end of 1H 2021. By the end of 1H 2021, of all active mobile-internet subscriptions 71% were to private consumers.

## Traffic

- The fixed lines generated 170 thousand hours of outgoing calls in 1H 2021, a decrease of 32 thousand hours (16%) compared to 1H 2020. In average, each fixed-telephone subscription generated 11 hours of outgoing calls during 1H 2021, equal to a decrease of 1.7 hours (12.8%) pr subscription compared to the same period the previous year.
- The mobile networks generated 1.6 million hours of outgoing calls in 1H 2021. A slight increase of 0.3% compared to the same period the year before. A mobile subscription generated 27.3 hours outgoing calls in average during 1H 2021, a decrease of 1 hour (4.1%) per subscription compared to 1H 2020.
- During 1H 2021, all mobile-broadband subscriptions generated 3.6 million GB of mobile-broadband internet traffic, an increase of 33% compared to the same period a year previously.
