Høvuðspunkt

Fastnet telefoni

- Tað vóru 14 túsund fastnet telefonhald ultimo juni 2022, ein minking uppá 500 hald (3%) samanborið við somu tíð árið frammanundan. Tað vóru 4,5 túsund VoIP hald ultimo juni 2022. Hetta er ein øking uppá 600 hald (15%), samanborið við ultimo juni 2021.

Fartelefoni

- Tað vóru 61,5 túsund fartelefonhald ultimo juni 2022, ein vøkstur uppá 1.700 hald (3%) samanborið við eitt ár frammanundan. Við endan av fyrri hálvu av 2022, hevði Føroya Tele ein marknaðarpart á 78 prosent, Nema hevði tey írestandi 22 prosent av marknaðinum.
- Við endan av fyrri hálvu av 2022 vóru tað 7 túsund maskinu-til-maskinu (M2M) fartelefonhald, ein vøkstur á umleið 1.600 hald (29%) samanborið við eitt ár frammanundan. Ultimo juni 2022 vóru meira enn 98 prosent av øllum M2M haldum vinnulig hald.

Internet

- Fastnet breiðband taldu 18,7 túsund hald við endan av fyrri hálvu av 2022, umleið 150 hald (1%) minni samanborið við árið fyri. Talið av haldum við einari marknaðarførdari ferð á omanfyri 30 Mbit/s hækkaði við 2.200 (19%), meðan hald við einari marknaðarførdari ferð á undir 30 Mbit/s minkaði samsvarandi (37%). Av øllum fastnet breiðbandshaldum høvdu 77 prosent eina marknaðarførda ferð omanfyri 30 Mbit/s við endan av fyrri hálvu av 2022.
- Tað vóru 60 túsund virkin mobil internethald við endan av fyrri hálvu av 2022, ein øking við 1.000 haldum (2%) samanborið við somu tíð árið frammanundan. Talið av fartelefonhaldum við atgongd til data øktist til 54 túsund við endan av fyrri hálvu av 2022. Harvið høvdu næstan 90 prosent av øllum fartelefonhaldum atgongd til data. Av øllum virknum mobilum internethaldum vóru 71 prosent privat ultimo juni 2022.

Ferðsla

- Fastnet linjur framleiddu 160 túsund tímar útgangandi køll í fyrri hálvár 2022, ein minking uppá 10 túsund tímar (6%) samanborið við fyrri hálvár 2021. Í miðal framleiddi hvør fastnet telefon 11 útgangandi tímar í leypi av fyrri hálvu av 2022, sum er ein hálván tíma (3%) minni enn sama tíðarskeið árið frammanundan.
- Fartelefoni kervini framleiddu 1,4 mió. tímar útgangandi køll fyrri hálvár 2022. Samanborið við sama tíðarskeið árið frammanundan, er talan um eina minking við 230 túsund tímum (14%). Í miðal framleiddi hvørt fartelefonhald 22,7 útgangandi tímar í leypi av fyrri hálvári 2022. Hetta er ein minking uppá næstan 4,5 tímar (4%) fyri hvørt haldið, samanborið við fyrri hálvár 2021.
- Í fyrri hálvu av 2022 framleiddu øll mobil breiðbandshald 4,2 mió. GB av mobilari breiðbandsferðslu. Nýtlan fevnir um alla nýtslu hjá føroyskum mobil breiðbandshaldum, bæði í og uttanfyri Føroyar. Tað er ein hækking á 600 túsund GB (18%) samanborið við sama tíðarskeið árið fyri.



Highlights

Fixed telephony

- There were 14 thousand fixed-telephone subscriptions at the end of 1H 2022, a decrease of 500 subscriptions (3%) compared to a year previously. VoIP subscriptions increased to 4.5 thousand subscriptions by the end of 1H 2022, 600 subscriptions (15%) more compared to the end of 1H 2021.

Mobile telephony

- There were 61.5 thousand mobile subscriptions at the end of the 1H 2022, an increase of 1.700 subscriptions (3%) compared to a year previously. At the end of 2022, Føroya Tele held a marked share of 78%, while Nema held the remaining 22% market share.
- By end of 1H 2022 there were 7 thousand Machine-to-Machine (M2M) mobile-subscriptions, an increase of 1.600 subscriptions (29%) compared to one year prior. By end of 1H 2022, 98% of all M2M subscriptions were business subscriptions.

Internet

- Fixed-broadband counted 18.7 thousand subscriptions by the end of 1H 2022, approximately 150 subscriptions (1%) less compared to a year previously. Subscriptions with an advertised speed above 30 Mbit/s increased by 2.2 thousand (19%), while subscriptions with an advertised speed below 30 Mbit/s decreased equivalently (37%). Of all fixed broadband subscriptions, 77% had an advertised speed above 30 Mbit/s by end of 1H 2022.
- There were 60 thousand active mobile-internet subscriptions by the end of 1H 2022, an increase of one thousand (2%) compared to one year before. At the end of 1H 2022, the number of mobile telephone subscriptions with data access increased to 54 thousand. Thereby, almost 90% of all mobile-telephone subscriptions had data access by the end of 1H 2022. By the end of 1H 2022, of all active mobile-internet subscriptions 71% were to private consumers.

Traffic

- The fixed lines generated 160 thousand hours of outgoing calls in 1H 2022, a decrease of 10 thousand hours (6%) compared to 1H 2021. In average, each fixed-telephone subscription generated 11 hours of outgoing calls during 1H 2022, equal to a decrease of half an hour (3%) per subscription compared to the same period the previous year.
- The mobile networks generated 1.4 million hours of outgoing calls in 1H 2022. A decrease of 14% compared to the same period the year before. A mobile subscription generated 22.7 hours outgoing calls in average during 1H 2022, a decrease of 4.5 hours (17%) per subscription compared to 1H 2021.
- During 1H 2022, all mobile-broadband subscriptions generated 4.2 million GB of mobile-broadband internet traffic, an increase of 600 thousand GB (18%) compared to the same period a year previously.
